Nationality

- You must possess Indian citizenship, which can be acquired either by birth or through registration.
- Applicants from foreign nations must possess a certificate of eligibility issued by the Government of India to appear for the WBCS exam 2023.

WBCS Eligibility Criteria 2023 - Age, Education

- You must hold a degree from a recognised university.
- Furthermore, you must possess the ability to read, write, and communicate either in Bengali or in Nepali. Nevertheless, if Nepali is your mother tongue, you are exempted from this requirement, in accordance with Finance Department Notification No. 1243-F(P) dated February 23, 2016.

Age Limit

- For Group 'A' and 'C' services and posts: Your age should be within the range of 21 to 36 years, with the birthdate falling between January 2, 1987, and January 1, 2002.
- For the West Bengal Police Service (Group 'B'): Your age should fall within the range of 20 to 36 years, with a birthdate between January 2, 1987, and January 1, 2003.
- For Group 'D' services and posts: Your age eligibility spans from 21 to 39 years, with a birthdate between January 2, 1984, and January 1, 2002. If your birthdate falls between January 1, 2002, and January 1, 2003 (making you 20 to 21 years old as of January 1, 2023), you are eligible to apply for Group B only.

Moreover, there are several age relaxation policies; let's delve into them.

Age Relaxation

- SC and ST candidates may receive up to 5 years of age relaxation
- Furthermore, OBC (Non-Creamy Layer) candidates are eligible for a 3-year relaxation.
- Additionally, individuals with benchmark disabilities (PwBD) possessing a disability level of 40% or more can have their upper age limit extended by up to 45 years.
- Lastly, It's worth noting that SC, ST, and O.B.C. candidates from other states will be considered for unreserved posts exclusively.

Other Requirements

The candidate should be in excellent health, possess a good character, and demonstrate suitability in all aspects for appointment to Government Service.



Preliminary Exam

- The Prelims exam will feature 200 multiple choice objective type questions.
- Moreover, this exam will carry a total of 200 marks and will last for a duration of 2.5 hours.
- Lastly, the content of the paper will align with the expected knowledge level of a graduate from any recognised university, regardless of their specific field of study.

Main Exam

- The Mains exam will include both objective and conventional type questions.
- Moreover, the Mains Examination comprises six compulsory papers. Additionally, if you are applying for Groups A and/or B, you are required to select one optional subject from the list provided in the WBCS Notification 2023.
- This optional subject is further segmented into two papers, Paper 1 and Paper 2, with each carrying a weightage of 200 marks.

Personality Test

When you successfully clear the Mains exam, you will be called for the Personality Test. Moreover, the objective of this test is to assess your personal attributes, including quick thinking, clear and logical expression of ideas, intellectual and moral integrity, leadership qualities, and the breadth of your interests. Additionally, the assessment will encompass questions related to a wide range of general topics of interest.
